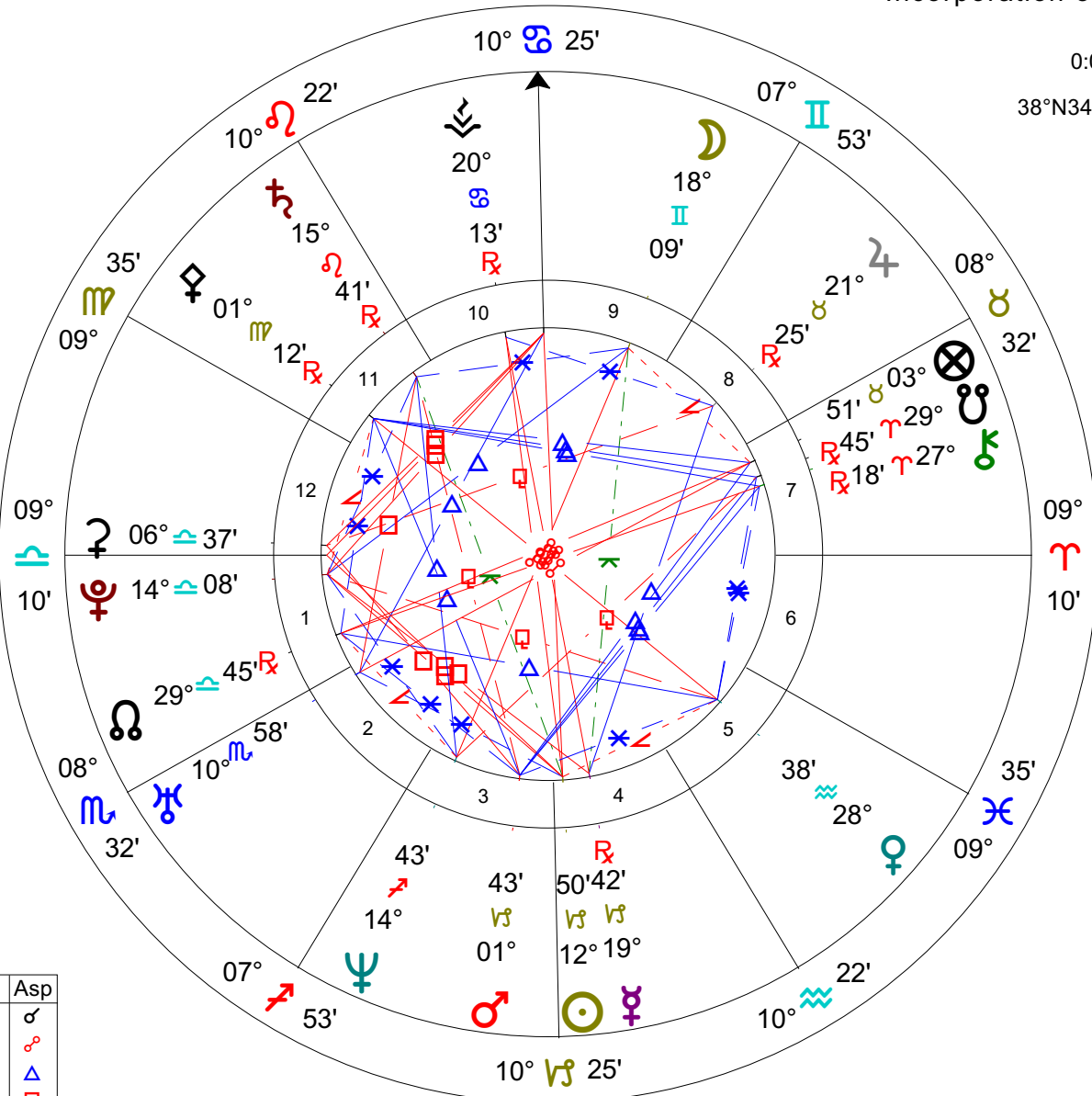

- I. Establish fee schedule prior to beginning and what will be required of client.
- II. Questionnaires:
  - a. For an already established company. See existing template.
    1. Chart Data? Timed, doors opened, took in first dollar.
    2. When did you send the papers in to be recorded?
  - b. For an about to be established company. Add the following.
    1. Non-astrological question. Have you had experience in this field?
    2. When do you plan to start? Key question.
    3. What type of business? ID significator.
    4. What is chart data of owner(s)?
    5. Is it a sole proprietorship, partnership, etc.?
    6. Location of new business? Is it a website launch, and then use that location.
    7. How are you financing this?
- III. Moon Phase is important.
  - a. New Moon (new starts) or Full Moon (re-organization)?
  - b. Eclipses? 90-days intervals.
  - c. Speed of Moon: Slow or Fast?
    1. Mean daily motion of Moon is  $13^{\circ} 10' 35''$ . If Moon is at  $11^{\circ}$  it is slow. At  $13^{\circ}$  Fast.
    2. If Moon is at Apogee, furthest from Earth, can be  $11.2^{\circ}$  day.
    3. If Moon is at Perigee, closest to Earth, can be as much as  $14.8^{\circ}$  day!

    4. Moon is the response of the public, the employees,
- IV. Pick a day that works for you the astrologer.
  - a. No Void of Course Moon or,  $29^{\circ}$  planets like Mercury, Mars, Venus, Sun.
  - b. What day of week best works with you or this type of company?
    1. e.g. Wednesday = Mercury day.
    2. Friday – Venus day.
  - c. Good aspects to your Mercury or ruler of  $3^{\text{rd}}$  or  $6^{\text{th}}$  helps.
  - d. Make sure by this time you have the owner's chart, this helps to decide.
- V. Electional chart qualifiers:
  - a. Distribution of planets is important.
    1. Angular is entity with more independence. *Flaw*: Issues of completion.
    2. Succedent is entity with fortitude, slower to take risks. *Flaw*: Risk averse.

3. Mutable is entity which requires business with no borders. Example being a sales business, consulting, writing, ideas, facilitation. *Flaw*: Could be too scattered.
  - b. What is the significator of this business and where will you place it? Its aspects?
    1. There will be a lot of discordant long-term aspects coming throughout time such as the 2012 to 2013 Uranus square Pluto. *This cannot be avoided* and has to be incorporated into a chart.
    2. What is the relationship between its Sun and Moon and Mercury?
      - a. Sakoian/ Acker formula
        - Mercury rising before Sun and Slow Moon = balance.
        - Sun rising before Mercury and Fast Moon = Balance.
        - Mercury rising before Sun and Fast Moon = Overly anxious.
        - Sun rising before Mercury and Slow Moon = Slow or plodding.
      - b. Mercury – What phase is it in? About to retrograde? Progression?
- VI. Other planets:
- a. Mars. Motivation. Phase? Know when planet goes retrograde or if it has gone direct.
  - b. Venus. Cash flow. Value system. Phase? (Ditto above).
  - c. Jupiter. Opportunity. Vision.
  - d. Saturn. Important to place well, it provides stability and foundation.
    1. What is the phase measurement between Saturn and Jupiter?
    2. Are there any recent Synodic Cycles? For example, Where was the last Saturn Jupiter in this chart?
- VII. Look at the chart from a different perspective or lens?
- a. 90-degree dial.
  - b. From the Sun's position is another way to do it.
  - c. From a 00° Aries Ascendant position.
